1. Type of the competition

- Outdoor Target archery – 70 M rounds
- The competition includes a qualification round (2x70m) according to the FITA rules, for the team ranking, followed by the Team-matches as per article nr . 5
- The procedure of the team event will take place on the principle of flights (see following rules). Each match is shot according to the FITA rules.
- Recurve Division only.
- Separate men and women events.
- Each clubteam is composed of 3 archers (each archer of the team has to belong to the same club).
- The 16 first men clubteams and the 16 first women club-teams teams from the qualification round are qualified for the Team-matches.
The ranking of the teams is obtained by adding the scores of the 3 archers of the clubteam at the end of the qualification round.
- If less than 16 clubteams take part in a category, only the first 8 clubteams of the qualification round, qualify for the match-event.
The other clubteams (ranked from the 9th to the 15th place) will compete in a “secondary round”. They shoot at the same time as the team-matches.
- A floating trophy, offered by EMAU (one for men, one for women) will be issued every year.
The winning teams will be in charge of the engraving of the trophies.
The clubteam which wins the trophy 3 times in a row, may keep the floating trophy permanently and a new trophy will be arranged by EMAU.

2. Selection of clubteams

- The EMAU Member Association takes care of its Federation's clubteam-participation.
- Number maximum of clubteams by country:
5 men clubteams and 5 women clubteams.
- A Club can participate with only one team men and one team women
- One clubteam is composed of 3 archers.
The members of the team must have all the same nationality which is that of the Member Association of which the Club is member.
- If there is a full selection there are **30** archers for one country.
5 women clubteams and 5 men clubteams.
Mixed teams are not accepted.
- The participating clubteams must be officially recognized by their Federation, according to their National Rules.
- Before being allowed to participate in the European Clubteams Cup, the Federation must confirm that the clubteam-athletes are members of the participating club as per the 1st January of that year.

3. Selection of the organizer

- Each year in July (Y) EMAU asks the EMAU Member Associations for bids for the organization of the European Clubteams Cup for the year (Y+1) and EMAU-council allocates the event for the year (Y+1).
- Deadline for such application is 31st October of the year (Y).
- The national federation selects the club who are organized the competition.

4. Program / Schedule

5. Rules

- All members of a team have to wear the same uniform.
- If a team arrived with more than 3 archers, they must communicate to the TD the names of the 3 archers composing the team before the end of the practice Session on Friday.
- The 3 archers of a team that shoot in the Qualification Round, have to shoot the team matches on Sunday. There is not possibility to change an archer during the competition.
- At the end of the individual qualification ranking round, the first 16 teams (men and women) are entered into 4 groups of 4 teams, according to the following scheme:

Group 1	Group 2	Group 3	Group 4
1 st	2 nd	3 rd	4 th
8 th	7 th	6 th	5 th
9 th	10 th	11 th	12 th
16 th	15 th	14 th	13 th

- In each group each team competes against the three others in the group.
At the end of these 3 matches, a ranking in each group is established by the allocation of following points :
 - won match 1 point
 - bye 1 point
 - lost match 0 pointAt this stage of the competition, all the teams have shot three matches.

Handling of ties:

- o Tie at the end of a match:
 - shoot-off according to the FITA rules
- o After the 3 group matches:
 - the total score of the 3 team-matches decides the tie
 - The scores of possible shoot off to decide one match will not take in count for this total.
- o when there is still a tie:
 - shoot-off according to the FITA rules

After the groups' matches, this is the situation:

* After the group-matches rounds, the first 8 teams (when there are 16 teams participating) or the first 4 teams (participation of 8 teams) will be allocated 1 extra point.

Ranking matches: 2 matches for all teams.

- **Match 1:** the teams at the same rank in the 4 groups meet to establish their final ranking:
teams of group nr. 1 meet the teams of the group 4
teams of group nr. 2 meet the teams of the group 3
- **Match 2:** the winners and the losers of the first match shoot against each other. If the timing allows it, the two winners amongst the 1st of match nr. 1, can shoot their (final) match separately, otherwise all teams shoot together.

At the end of the 2nd match:

the 1 st of each "group" are ranked from	the 1 st to the 4 th position
the 2 nd of each "group" are ranked from	the 5 th to the 8 th position
the 3 rd of each "group" are ranked from	the 9 th to the 12 th position
the 4 th of each "group" are ranked from	the 13 th to the 16 th position.

In case of a tie at the end of match nr 1 or 2:
shoot-off according to the FITA rules.

The winner of the final round of the European Clubteams Cup (men and women) wins the

6. Yearly planning:

July	EMAU writes to the Federations and asks for bids from organizers for the event for the following year
31 st of October	deadline for bids to be received by EMAU for the coming year
November	EMAU council decides on the bids and EMAU publishes the decision on the EMAU Website.
5 months before the event	The organizer send to EMAU all the information about (inscription, transport, hotel).
90 days before the event	EMAU MAS send the club-entries to the organizer together with the confirmation that a) the Clubs are members of the EMAU MAS and b) the archers are members of the participating club (article 2)
30 days before the event	Payment to be made as per the information in the invitation

7. Appointment of Judges

Judges-accommodation- and -travel-costs

- Number of judges 8 National and 2 Continental Judges.
- The host country carries the accommodation costs of all judges.(8+2)
- The host country will appoint 8 National Judges .
- EMAU will appoint 2 Continental Judges and carries their travel cost.

8. Entry fees

- EMAU council decides on the level of the entry fee (max Euro 150.- /clubteam).
- The participating Clubteams have to pay the entry fee and all the accommodation-fees as per the invitation-information, to the Organizing Committee 30 days before the competition (see article 6).

9. The field of play for the European Clubteams Cup

There will be 2 teams in a lane of 5 m. In this case, 16 lanes of 5 m are necessary which means: 80 m minimum.

It might be necessary to have some what smaller lanes when the FOP does not allow for 5 m. wide lanes.

The position of the judges must be discussed as per the availabilities on the FOP's.
